#### 1. Introduction

These Terms and Conditions apply to all transactions between Cross Blinds & Shutters ("we", "us", or "our") and our customers ("you" or "your"). By placing an order or using our services, you agree to be bound by these Terms.

#### 2. Quotations and Orders

- All quotations are valid for 30 days unless otherwise stated.
- Orders are confirmed upon receipt of a signed contract or written/email acceptance.
- We reserve the right to adjust prices if supplier costs or specifications change prior to order acceptance.

#### 3. Measuring and Installation

- We offer free home consultations, including measuring and product advice.

- It is your responsibility to ensure the installation area is accessible and prepared.

- Installation dates are estimates and may be subject to change due to product lead times or unforeseen delays.

#### 4. Products

- All blinds, flyscreens, and shutters are made to measure. Minor variations in shade, texture, or grain may occur.

- Product images on our website or brochures are for illustrative purposes only.

#### 5. Payment Terms

- A 40% deposit is required at the time of order for all made-to-measure products.
- A 50% deposit is required for shutters and flyscreens.

- The remaining balance is due on or before the day of installation, unless otherwise agreed in writing.
- Late payments may be subject to interest at 4% above the Bank of England base rate.

#### 6. Cancellations and Refunds

- As all products are custom-made, cancellations after production has begun are non-refundable.
- Faulty goods will be repaired or replaced in line with your consumer rights.
- Approved refunds will be processed within 14 working days.

#### 7. Warranties

- Blinds and flyscreens come with a 3-year manufacturer's warranty.
- Shutters are covered by a 3-5 year warranty, depending on the product type and manufacturer.
- Warranties cover manufacturing defects only.
- The warranty does not cover:
- Accidental damage or misuse
- General wear and tear
- Issues caused by moisture, pets, children, or incorrect use
- Modifications or repairs not carried out by Cross Blinds & Shutters or approved representatives

#### 8. Liability

We are not liable for indirect, incidental, or consequential losses. Our maximum liability will not exceed the total paid for the goods/services in question.

#### 9. Data Protection
